Portfolio-level monitoring: background

- Initially, no results-based management framework at the portfolio level -- a wide range of approaches to monitoring adaptation
- For early projects, adaptation outcomes difficult to verify at completion; completed projects report progress in enhancing enabling conditions
- Adaptation Monitoring and Assessment Tool from 2011: flexible menu of 50+ indicators corresponding to fund objectives and outcomes

Recent progress: portfolio results

Recent progress: evaluations and AMR

- Independent evaluations of the LDCF and the SCCF:
 - relevance of funds to COP mandate;
 - alignment of projects and programs with national strategies and plans, including NAPAs;
 - gender mainstreaming, stakeholder involvement
- Annual Monitoring Review:
 - portfolio-level performance based on 60+ LDCF and SCCF projects;
 - qualitative review against: success factors and challenges, mainstreaming, scaling up

The way forward

- Revised results framework for the GEF Adaptation Program (July 1, 2014):
 - Three objectives, ten outcomes captures the key dimensions and mandates of GEF support towards CCA
 - Indicators to be finalized by Oct 2014: seeking to move from outputs to outcomes on institutional and technical capacity building, mainstreaming
- Enhanced support towards **national systems** for monitoring, reporting, evaluation and learning
- We seek **input and experience** on methodologies and approaches, seek coherence with other funds
