

# Global Programme on Human Mobility in the Context of Climate Change (GP HMCCC) II

## Building Resilience in the ECOWAS Region: Human Mobility as Climate Adaptation.

### The Challenge

The Global Programme on Human Mobility in the Context of Climate Change (HMCCC) addresses challenges associated with climate-induced migration and displacement.

In the ECOWAS region over 7.5 million people have been internally displaced in 2022 due to extreme weather events and environmental changes. With economies highly dependent on climate-sensitive agriculture, communities are vulnerable to both sudden and gradual effects of climate change that threaten livelihoods.

Nine out of 12 ECOWAS countries are among the 30 most climate-vulnerable worldwide, where environmental degradation and conflict has worsened migration pressures. Gender dynamics also play a significant role, with **women disproportionately impacted by climate change**. However, strategies often overlook the root causes of gender inequality, limiting the effectiveness of efforts to empower women and marginalized groups.


**Data availability** is another challenge. Lack of gender disaggregated data is hindering the development of evidence-based, gender-responsive policies. While regional and international institutions provide valuable climate and migration data, gaps remain in local integration and application. The lack of cross-sectoral communities of practice further restricts systematic data use in policy development.

The ECOWAS Commission, through its **Regional Climate Strategy (2022)**, prioritizes the nexus between climate change, human mobility, and security. However, it is still in the early stages of building the necessary structures to address these interconnected challenges effectively. To support the ECOWAS Commission **long-term regional structures and capacities are needed to implement gender- responsive, city centric, conflict-sensitive approaches to human mobility**.

### Our Approach

The project addresses these challenges through a multi-level approach working with regional, national, and local actors to implement climate- resilient, gender-responsive and conflict-sensitive HMCCC approaches. The approach is based on best practices developed in the first project phase (2017-2023) and focuses on four principles:
